## Our History

Nestled in the hills of north central Massachusetts along the Tully and Millers River, Athol boasts of a rich past that has retained a strong influence on the current character of the town. After the King Philip's War in 1676, European settlers founded a community in the area centered around farming and hunting. Developed in the 1730s, this community was known as the Pequoiag.

In 1762, the town was incorporated and renamed Athol. By the end of the centur

saw, and fulling mills powered by the two rivers were the leading employers for Athol residents. Over the course of the 1800s, the industrial sector boomed for many mill towns across the United States, including our town. As a result of this growth and the need for larger scale regional connectivity, new railroad construction commenced linking Athol to larger cities in the region,

Springfield, Fitchburg, and parts

Vermont.




by Laroy S. Starrett. Thirteen years later, Mr. Starrett founded the L.S. Starrett Company, now an international company still producing high-quality precision tools. In 1905, the Union Twist Drill Company opened a mill that manufactured metal cutting tools and quickly grew to become the second largest employer in Athol. These two companies helped create Athol's legacy as the "Tool Town." To this day, the Starrett Mills dominate the downtown landscape along the Millers River and the company remains

the largest local employer.

Athol has retained much of its historic character through the preservation of buildings

from previous eras - this is particularly evident in the downtown area. The town and North Quabbin region are blessed with natural beauty and many recreational opportunities. From camping, to swimming, to fishing, to hiking trails with stunning vistas, the area is rife with opportunities to interact with nature. Today, Athol is a safe and affordable community that nearly 12,000 people call home.

# Permits in Athol

### The Department of Planning and Development

The Department of Planning and Community Development works closely with the Board of Planning and Community Development (BPCD), which issues the following permits:

## Site Plan Review Application Special Permit Application Form

When undertaking any new building construction over 5,000 sf, a site plan review approval is required.

The BCPD issues special permits for licensed marijuana estabilshments, flag lots, open space residential design (OSRD), ground-mounted solar photovoltaic installations, and projects included in the Mill Revitalization Overlay District. Other special permits are issued by the Zoning Board of Appeals.

### **Building Department**

All business must first start in the Building Department to see if the business is allowed under our zoning bylaws.

These forms must be completed to ensure compliance with all Athol building code regulations. Any and all changes to existing structures, along with additions, will be covered by these.

In compliance with all regulations, these forms must be filled out to ensure safety from building emergencies.
